About the NEL VCFSE Collaborative

The North East London (NEL) Voluntary, Community, Faith and Social Enterprise (VCFSE) Collaborative works closely with [NHS North East London](#) to provide strategic input and representation for the VCFSE across NEL. The NEL VCFSE collaborative currently meets monthly and aims to ensure a two way flow of communication from VCFSE to ICB.

In June 2025 we appointed our representatives which include seven place-based representatives and five thematic representatives. Together they'll provide strategic leadership and work closely with the ICB and wider partners to ensure parity in collaboration and further advocate the VCFSE in its role in addressing health inequalities and supporting health and wellbeing across NEL.

The NEL VCFSE Collaborative is committed to our five values:

1. Equity and inclusivity - Championing compassionate, collaborative, and inclusive multi-professional leadership.
2. Collaborative – Meaningful integration with the ICB as a coordinated VCFSE voice.
3. Innovative – VCFSE sector contributing expertise in an equitable manner in commissioning, service design and improvement processes.
4. Transparent – Building trust across sectors and ensuring the VCFSE is a valued partner.
5. Person and community focused – Strengths-based approach by championing our people and communities.

Background

Integrated Care Systems (ICSs) were set up on 1st July 2022 in order to improve the health and wellbeing of people across a sub-regional area and comprise an Integrated Care Partnership and an Integrated Care Board. They exist to support integration and partnership with health & social care organisations to improve population health, build greater equity and reduce health inequalities.

NHS England guidance for the implementation of ICS requires the establishment of a 'VCSE alliance', and targets to enable this have been set:

"By [July] 2022 integrated care partnerships (ICPs) and the ICB are expected to have developed a formal agreement for engaging and embedding the VCSE sector in system-level governance and decision making arrangements, ideally by working through a VCSE alliance to reflect the diversity of the sector."



Peter Laing – Newham representative
